THE PAYMENT MUST BE DONE WITH THE F24 FORM (MODELLO F24) USING THE RATES INDICATED IN THE TABLE BELOW. THE TAX BASE ON WHICH YOU CAN APPLY THE TASI IS THE SAME AS IMU. START FROM THE CADASTRAL REVENUE REVALUED ON 5% AND MULTIPLY THE RESULT WITH THE COEFFICIENT OF THE BUILDING. ON THIS YOU HAVE TO APPLY THE TASI RATE AND DEDUCT ANY DETRATIONS IN THE MEASURE OF PROPERTY PERCENTAGE.

YOU HAVE TO PAY BY MODELLO F24, USING RATES WRITTEN BELOW.

**0,895%** buildings cadastred or that can be cadastred in the cadastral category C/1;

housing untis, except cadastral categories A/1, A/8 and A/9, given by the possessor to relatives in free use; the relatives must be within the first grade (e.g. father and son) and in collateral line within the second grade (e.g. brother and sister) with the condition that the relative and its family live regularly and have the registered residence in the above-mentioned building. In this rate are also included related amenities of cadastral categories C/2, C/6 ad C/7, in the maximum extent of one pertinence unit for each one of the cadastral categories above-mentioned. You have to present the apposite model (downloadable form the City Hall website or available at the City Hall's offices) at Tax Office before 30.06.2015.

**0,400%** housing units used as main habitation, cadastred in the categories A/1, A/8 and A/9, and their related amenities included in the categories C/2, C/6 and C/7, in the maximum extent of one pertinence unit for each one of the cadastral categories above-mentioned;

**1,060%** all the other buildings for whom the tax is due but that weren't mentioned in the precedent casuistries (e.g. second houses, second garages, building areas, rural areas).
